ARTICLE I - NAME

ARTICLE III - PURPOSE and TERM

The purpose for which this non-profit corporation is established is: to provide an entity for the operation, administration and maintenance of the Condominium known as:

ARTICLE IV- MANNER OF ELECTION

The directors of the Association shall be elected by the Unit owners as set forth in the Bylaws or as provided for in Chapter 718, Florida Statutes, The Condominium Act, as amended.

ARTICLE VI - POWERS

The powers of the Association shall include and be governed by the following provisions:

- 1. To make and collect assessments against members.
- 2. To use the proceeds of assessments in the exercise of its powers and duties.
- 3. The maintenance, repair, replacement and operations of the Condominium property.
- 4. The purchase of insurance upon the Condominium property and insurance for the protection of the Association and its members.
- 5. The reconstruction of improvements after casualty and the further improvement of the property.
- 6. To make and amend reasonable rules and regulations respecting the use of the property in the Condominium.

The powers of the Association shall be subject to and shall be exercised in accordance with the provisions of the Declaration of Condominium and the Bylaws.
