ARTICLES OF INCORPORATION OF WEST BAY CLUB PROPERTY OWNERS ASSOCIATION, INC.

These Articles of Incorporation are signed and acknowledged by the incorporator for the purpose of forming a not-for-profit corporation under the provisions of Chapter 517 of the Florida Statutes known as the Florida Not For Profit Corporation Act, as follows:

ARTICLE I

The name of the corporation is: WEST BAY CLUB PROPERTY OWNERS
ASSOCIATION, INC.

ARTICLE II

The term of this corporation is fixed in perpetuity and is to commence when these: Articles of Incorporation are filed with the Department of State. \Box

ARTICLE III

Section 1. This non-profit corporation is organized to sustain property values and to promote the recreation, aesthetic enjoyment and social welfare of the owners and occupants of the parcels within West Bay Club Subdivision, and in general, to exercise any, all and every power for which a corporation organized under the Florida Not For Profit Corporation Act can be authorized to exercise.

Section 2. All of the property of this corporation and any accumulations thereof shall be held and administered to effectuate these purposes. In the event of dissolution, the assets of the corporation shall be distributed pursuant to a Plan of Distribution adopted in accordance with section 617.1406, Florida Statutes or such other law as may be applicable

at the time, to the end that any assets of the corporation shall be returned to the members of the corporation to the fullest extent legally permissible.

ARTICLE IV

The initial registered office is located at: 22199 Natures Cove Court, Estero, Florida 33928, and Donald Vilnius is the initial registered agent.

ARTICLE V

- Section 1. The powers of this corporation shall be exercised, its properties controlled and its affairs conducted by a Board of Directors.
- Section 2. The number of directors shall be as provided in the Bylaws of the corporation, but the number shall never be less than three (3).
- Section 3. The directors shall be nominated, elected and shall serve in the manner provided in the Bylaws of the corporation.

ARTICLE VI

The qualification for membership and the manner of admission of members shall be as provided in the Bylaws of the corporation.
