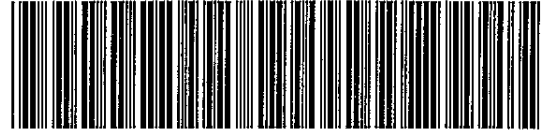


ARTICLE VII – AMENDMENTS


ARTICLES VIII – DISSOLUTION

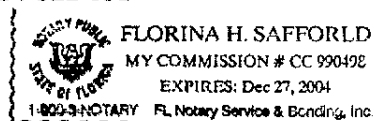


