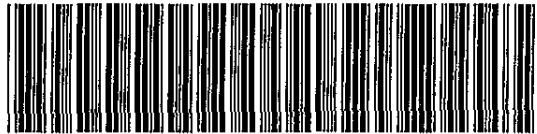

ARTICLE THREE - PURPOSES

ARTICLE THREE - PURPOSES

The purpose for which this corporation is organized as a non-profit corporation in accordance with the provisions of Chapter 617, under the Florida Not for Profit Corporation Act, is to operate an organization that will train and equip people to advance the cause of Christ through ministries that educate, edify and evangelize.

- a) The said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

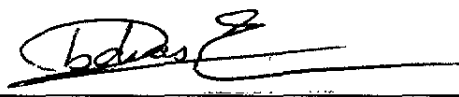
