# ARTICLES OF INCORPORATION DADE CITY WIDOWS MITE, INC. (A Corporation not for profit)

In compliance with the requirements of Florida Statute Chapter 617, the undersigned, being natural persons, hereby act as incorporators in adopting and filing these Articles of Incorporation for the purpose of organizing a corporation not for profit.

## **ARTICLE I**

The name of the corporation is: Dade City Widows Mite, Inc.

## ARTICLE II

ARTICLE III

## **ARTICLE IV**

The specific and primary purposes for which this corporation is formed are:

- Α. To provide financial and educational assistance to widows, orphans, homeless and other persons in need of financial and informational assistance.
- В. To host seminars, conferences, lectures and educational courses, to issue publications, and to conduct fund-raising and other educational activities.
