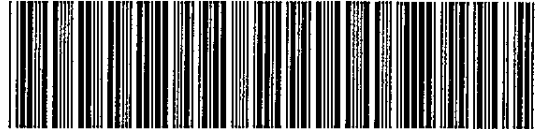

ARTICLE I. CORPORATE NAME

ARTICLE III. TERM OF EXISTENCE

The period of duration of this corporation is perpetual.

ARTICLE IV. PURPOSES

The purposes for which the corporation is organized are:

To assist Families and individuals with Family services Provision including and not limited To: Housing, Credit Restoration, Counseling, Educational Programs and Economic Development and Self Sufficiency Training and Guidance Services.

Further goals and purposes of this corporation are:

1. To educate the general public, businesses, institutional and governmental bodies of the Long term benefits of sustainable development and construction of Family Services corporations,
2. To promote and educate the public about Safe Affordable Family Services and Human Services practices;
3. To improve the creditworthiness of clients, provide training and education materials in energy efficiency, energy conservation potential, indoor air quality, Water conservation potential and sustainability of family services buildings;
4. To encourage Safe Affordable Family Services and – Housing affordability by increasing access to capital for building family homes.
5. To stimulate statewide acquaintance and fellowship among members and others Interested in Safe Affordable Family Services and -practices;

ARTICLE VII. BOARD OF DIRECTORS

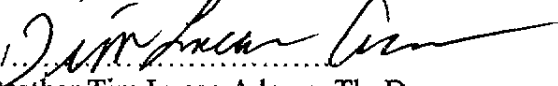
The internal affairs of the corporation shall be managed by a Board of Directors consisting of no more than 3 individuals.

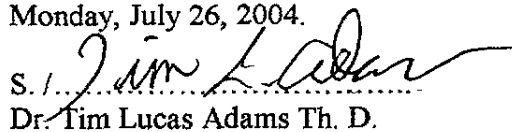
