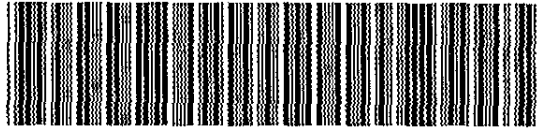

We, the undersigned, with other persons being desirous of forming a not-for-profit corporation for philanthropic and educational purposes under the provisions of chapter 617 of the Florida Statutes do agree to the following:

**ARTICLE I**  
(NAME)

The name of the Corporation shall be **EMILIO PUJOL FOUNDATION, INC.**

**ARTICLE II**  
(PRINCIPAL OFFICE)

The Principal place of business and mailing address of this corporation shall be:

**ARTICLE III**  
(PURPOSE)

The purpose of this corporation is to promote and foster all expressions of art through the study and execution of Classical and Folkloric guitar music, bringing into close association the peoples of the various national and ethnic groups in the area. The following Objectives describe how the Emilio Pujol Foundation will achieve its objectives:

Foster a spirit of understanding, tolerance and good will among the different ethnic groups in the area, presenting to the general public educational and cultural programs for the benefit of our communities, providing educational institutions the opportunity to participate in our activities or utilize our resources for their own educational and cultural endeavors.

Promote the study of Classical Guitar technique an repertoire following the guiding principles of the School of Tarrega compiled by Maestro Emilio Pujol in his method and teaching notes.

Make available Emilio Pujol's unpublished material on Classical guitar study and pedagogy to educate Foundation members and the public in general in the importance of his contribution to the pedagogy of Classical Guitar.

Help outstanding guitar students with grants, scholarships or tuition helps to improve further their mastery of the instrument.

Organize and sponsor conferences, gatherings and concerts inviting renowned guitar masters in the area and for the exposure of new talents to a wider network of contacts in the local Classical Guitar environment.

Interact and form partnerships with other cultural associations , Schools , Universities or Art institutions in the area to collaborate in the promotion of cultural events, sponsoring , co-sponsoring or supporting the logistic organization of these events.

Sponsor the formation of Classical Guitar study groups fostering practice and discussion of contemporary and classical guitar methods, promoting the interchange of ideas and techniques on guitar playing, research the history and technique of the classical guitar and share this knowledge with the cultural and music department of the different institutions.

Expand the horizons of guitar performance by exploring Classical as well as Folkloric and contemporary music where Guitar or other stringed instruments are used.

Define the operation of the Foundation as a Non-For Profit organization. All funds collected are to be used on the above goals of the Foundation to present the Classical Guitar via concerts and conferences, and to help deserving students in their goals to perfect their technique on the instrument.

#### **ARTICLE IV**

##### **(MANNER OF ELECTION)**

The officers shall be elected at the annual meeting of the Board Directors or as provided in the By-Laws. The initial officers are appointed on an interim basis with a mandate to establish the initial corporation organization, enroll members and conduct the first Board Of Director Meeting to elect officials.

#### **ARTICLE V**

##### **(BOARD OF DIRECTORS/OFFICERS)**

The business affairs of this corporation shall be managed by the board of directors. This corporation shall have three (3) directors initially. The number of directors may be either increased or decreased from time to time but shall never be less than one (1).
