ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

ST. JOHN'S CATHEDRAL SCHOOL & EARLY LEARNING CENTER, INC.

Pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, as amended, and Article XI of the Articles of Incorporation of St. John's Cathedral School & Early Learning Center, Inc., Inc. (the "Corporation"), the Articles of Incorporation of the Corporation are amended as follows:

1. Article III is amended to read:

ARTICLE III

Qualification of Members: Meetings of Members.

The membership of the Corporation shall consist of the individuals who serve as the Rector and members of the Vestry of The Rector, Wardens and Vestry of St. John's Parish at Jacksonville, Florida, or their successors in office. Meetings of the Members of the Corporation may be called by the Chairman, Vice Chairman or 1/3 of the Members of the Corporation, and also by such other means as may be specified in the Bylaws, in each case upon five (5) days' written notice to the Members of the time and place of such meeting.

2. Article IV is amended to read:

ARTICLE IV

Term

The Corporation shall have perpetual existence. Upon the dissolution of the Corporation or the winding up of its affairs or other liquidation of its assets, the Corporation's property shall be distributed to The Rector, Wardens and Vestry of St. Johns Parish, at Jacksonville, Florida, or such other 501(c)(3) organization as the Members shall determine; and in no event shall any such distribution be made to any individual or to any entity created or operated for profit.

- 3. Article V of the Articles is amended by adding the following paragraph (k) at the end of the Article:
- (k) The Corporation shall be subject to the provisions of Section 617.0808(1), Florida Statutes.
 - 4. Article X is amended to read:

ARTICLE X - By-Laws

Bylaws of the Corporation may be adopted and amended by a majority vote of the members of the Corporation at any annual meeting, or at any special meeting called for that purpose.

5. Article XI is amended read:

ARTICLE XI -- Amendments

The Members of the Corporation may amend these Articles by a two third's vote of the Members. Written notice of the proposed amendment(s) must be furnished to all Members not less five (5) days prior to the meeting in which the amendment is to be considered.
