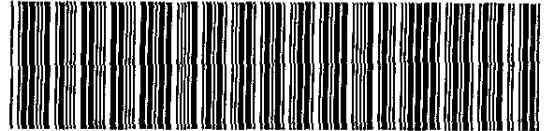

To bring the renaissance type art to the people that can not afford to visit the many places of art in Italy and Europe. To sculpt / paint etc. and to donate the finished art work to Churches and places of a religious nature. To open a school for the arts as described above. To attend schools to better understand and to be able to teach as to methods used in sculpture of marble and frescos, murals, wood sculptures

The art of that era was to help illiterate people enjoy their faith through seeing and not reading as the only people at that time that could read and write were the priests. The people needed to see the statuary the murals and the frescos to give them the deep feeling of their faith. *"This today is called visual aids."*

The encyclical from Pope John Paul, "Sacramentum Concillium" states there should be a school that teaches sacramental art in each diocese, teaching and instructing in all phases of art as were bestowed on the two in the Old Testament under Exodus Chapters 34 and 36 and others stating the "Gifts of the Artisans".

Art is a gift we bestow upon our future generations a gift we leave behind us, something to show the world of the future we were here and we left something for you to admire and enjoy, this is what this Foundation is for. To bequeath to the future generations, art worthy of leaving behind something as the great renaissance artists did for our pleasure and enjoyment. At that time they had no other means of sculpture then a hammer and chisel, compared to what we have now. What will the future bring for art?


