## Amendment: Article III, Section E, Articles of Incorporation

## ARTICLE III

PURPOSE AND POWERS. The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act for the operation of SUNSET GULF, a Condominium, located in Lee County, Florida.
