ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit).

ARTICLE I: NAME

The name of the Corporation shall be:

THE ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose for which the corporation is organized:

General Assembly Church, Inc. is a non-profit corporation committed to serve families in the State of Florida through teaching spiritual, moral, educational and social values to its members. The following instructions describe the purpose of the General Assembly Church, Inc.

1. General Assembly Church, Inc. is a Christian assembly and a non-profit corporation.
2. This Church believes in God and Jesus Christ and uses the bible as its main source.
3. This Church's specific purposes shall be to spread the Christian faith (Mathew 22:37-39) in accordance with its bylaws and in accordance with the policies approved by the Board of Directors.
4. It respects the laws of the State of Florida and the Country in general as well as the Divine Law described in the Holy Scriptures.
5. It makes God's will while keeping its commandments, as being the fundamental Law of the Jesus Christ Gospel.
6. It ministers the word of God to the Faithful (Acts 6:4) to conduct regular religious worship services through various forms of ministries and to promote and encourage those that are in need through the various ministries of the church (1 Thessalonians 5:11 and James 1:27).
7. It cooperates with other organizations and institutions in ministering God's Word (1 Corinthians 1:10 and Ephesians 4:4) to spread the Gospel of Jesus Christ by ministering through bible studies, fellowships, and other forms of communication (Romans 10:15).
8. It shall maintain a local church (Hebrews 10:25) as well as to implement a program of planting new churches in the State of Florida (Mark 16:15, Acts 1:8-9).

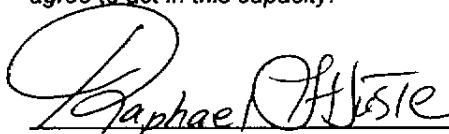

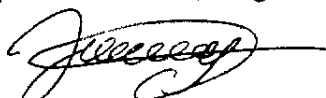
