Articles of Incorporation

ARTICLES OF INCORPORATION

OF

Society of St. Agnes Incorporated

ARTICLE I: NAME

The name of this corporation shall be Society of St. Agnes Incorporated.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE


