

The undersigned incorporator, being a natural person of the age of twenty-one years or more and a citizen of the United States, for the purpose of forming a corporation under the provisions of Chapter 617 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I – NAME

The Corporation is organized exclusively for charitable, literary, scientific and educational purposes as set forth in Section 501(c)(3) of the Internal Revenue Code.


ARTICLE IV – MANNER OF ELECTION
