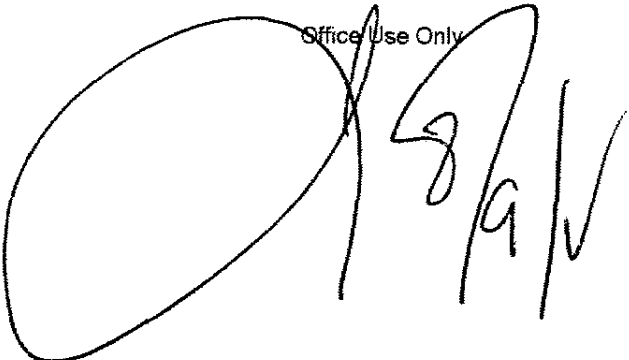

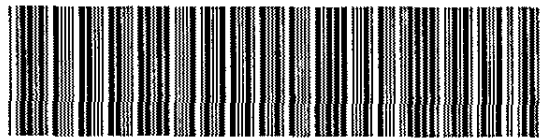

ARTICLE I – NAME

The name of the nonprofit corporation shall be known as the House of God Miracle Temple of Miami, Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business and mailing address of the nonprofit corporation shall be 6431 S.W. 59 Avenue, South Miami, Florida 33143.

ARTICLE III – PURPOSE

The House of God Miracle Temple of Miami, Inc. (hereinafter sometimes referred to as the “Church” or “Corporation”) exists for the purpose of communicating the gospel of Jesus Christ, His atonement, His Lordship, for the encouragement of His Saints. The Church is comprised of members who have confessed their sin and their commitment to Christ and His leading of their lives. The Church is commissioned by Christ to maintain and to expand His Kingdom through the ongoing, Spirit-led work of Evangelism, Bible Study, Worship, Prayer and Fellowship.

The general nature of the object of the Corporation shall be to affirm the Holy Bible as the inspired word of God and the basis for our beliefs. This Church subscribes to the doctrinal statement that, “*We are built upon the foundation of the Prophets, and the Apostles with Jesus Christ, Himself, being the Chief cornerstone.*” We voluntarily band ourselves together as a body of baptized believers in Jesus Christ personally committed to

sharing the good news of salvation to lost mankind. The ordinances of the Church are the believers' baptism in the name of Jesus Christ and the Lord's Supper.

ARTICLE IV – MEMBERSHIP

The Corporation shall have no capital stock and shall be organized on a membership basis. The terms of admission to membership of the corporation shall be as directed in the Bylaws of this Corporation. The Corporation shall have voting members as determined in the Bylaws of the Corporation with all rights and privileges as outlined herein or in the Bylaws. The Bylaws may provide for nonvoting members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as set forth in the Bylaws.

ARTICLE V – INITIAL BOARD OF TRUSTEES (DIRECTORS)

The management of the Corporation shall be vested in a Board of Trustees. The number of Trustees constituting the initial Board of Trustees is eleven (11). The number of Trustees may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three (3). Any voting members shall have the right to nominate a voting member of the Corporation for a term of service on the Board of Trustees. The nominated person shall require the approval to a majority of the Board of Trustees in order to become a member of the Board of Trustees. The Bylaws may provide for *ex officio* and honorary Trustees, and their rights and privileges.

The Trustees, subsequent to the Initial Board of Trustees, shall be elected at the annual election meeting of the Board of Trustees. The initial Board of Trustees shall serve until their successors have been elected. Provisions for the qualifications, election, removal, disqualification and resignation of Trustees and for filling vacancies on the

Board of Trustees shall be established by the Bylaws of the Corporation. The name and address of each initial Trustee of the corporation is as follows:

ARTICLE VI – OFFICERS

The principal officers of the Corporation shall consist of a President, Vice President, Secretary and Treasurer. Each principal officer shall exercise such powers and

duties as granted by the Board of Trustees and as provided for in the Bylaws of the Corporation. Each principal officer shall hold a seat on the Board of Directors by virtue of his or her office. Provision for the election, removal, disqualification and resignation of a principal officer, and for filling vacancies in a principal office shall be established by the Bylaws of the Corporation.

The Corporation may establish such other officers and assistant officers as may be provided in the Bylaws. Each principal officer established herein shall be elected by the Board of Trustees and may be removed by the Board of Trustees at such time and in such manner as may be prescribed by the Bylaws. ARTICLE VII – AMENDMENT

These Articles of Incorporation, or any provisions thereof, may be amended or altered by a majority vote of the Board of Trustees present at a regularly scheduled or specially called meeting of the Board of Trustees.

The Corporation, by and through its Board of Trustees, reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Trustees and Officers are subject to this reservation.

ARTICLE VIII – BYLAWS

The power to adopt, alter, amend and repeal the Bylaws shall be vested in the Board of Trustees.

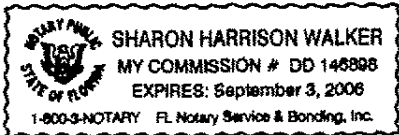
