ARTICLES OF INCORPORATION OF LEMON BAY YACHT CLUB, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person, hereby form a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name or the corporation shall be LEMON BAY YACHT CLUB, INC. $\overset{\circ}{\omega}$

ARTICLE II: STATEMENT OF PURPOSES

This corporation is formed for the purposes of promoting and supporting the enjoyment and preservation of Florida's freshwater and saltwater natural resources and facilities and to provide educational and recreational activities related to boating and other water sports. Membership shall be non-discriminatory and open to the public subject to the requirement that members meet reasonable eligibility criteria and pay all dues and assessments which may, from time to time, be required, and regularly attend meetings of the asociation.
