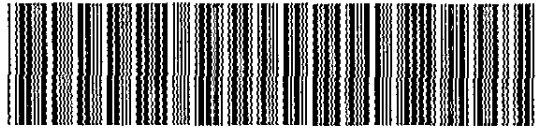

SECTION 11

Article One

The name for the corporation is Open Arms & Hearts Ministries Inc.

ARTICLE TWO

The principal place of business and the mailing address of this corporation shall be 3534 Smithfield rd. Jacksonville, FL 32217

ARTICLE THREE

The general purposes for which this corporation is formed are to train men and women the skills of music and video production for the music ministry of the church to qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1985, as amended, or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code, as may be amended from time to time. There will be no form of gambling such as bingo raffles or lotteries. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE FOUR

The manner of which the directors are elected or appointed: each officer will be appointed by the President, termination of officers of the corporation can only be done by a unanimous vote of the Executive Staff.

ARTICLE SEVEN

This corporation shall have a perpetual existence.

ARTICLE EIGHT

Corporate members and supporting members of the corporation shall be in good standing, only corporate members shall have voting privileges.

ARTICLE NINE

To become a part of the corporation a desire for the music and video production must be given and a willingness to honor and abide by the constitution and By-Laws of the corporation must be expressed.

This corporation commences and its operations outlined in the Articles of incorporation upon filing of said Articles of Incorporation with the secretary of the commonwealth of Florida.

ARTICLE ELEVEN

Anthony Hatten shall serve as the President and Chief -Executive of the corporation and the only one with power to appoint officers to any vacant office. The appointed officers shall be known as the Executive Staff, Vice -President, Recording-Secretary, Treasurer and Financial-Secretary.

a) Anthony Hatten the founder of said corporation and Chief-Executive shall remain in office as President and Chief -Executive until death the vice president will then move up to president when that time comes, any officer who wishes to resign must do so in writing two weeks before the effective date.

b) All officers must have a mind to work hard and be ready to learn and to teach any one with the desire to learn. all officers appointed shall serve for a term of twenty(20) years.

c) The President shall sign all certificates, contracts, deeds, and other investments of the corporation. All real estate and properties purchased in the name of the corporation shall be owned by the corporation, real estate or other property may be acquired by purchase, gift, devise or deed. Said property shall be held in trust for use and benefit of A & J Video Production Inc

d) Special meetings may be called by written or verbal notice to all members at least five (5) days prior to said meeting.
