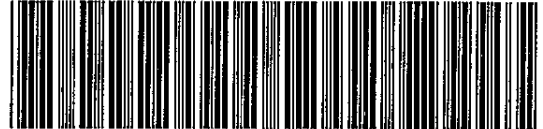

ARTICLES OF INCORPORATION
OF
Everything Under The Son Ministries Inc.
(In compliance with F.S. Chapter 617 Not for Profit)

ARTICLE I - (Name)
F.S. 617.0202 (1) (a), IRS 501 (c) (3)

The name of this corporation shall be: Everything Under The Son Ministries, Inc.

ARTICLE II - (Place of Business)
F.S. 617.0202 (1) (b), IRS 501 (c) (3)

ARTICLE III - (Statement of Purposes)
F.S. 617.0202 (1) (c), IRS 501 (c) (3)

The overall purposes for which this corporation is organized and operated are exclusively religious, educational and charitable.

The general purpose for which this corporation is formed is:

- 1) To advance, establish, promote and multiply the effects of the Kingdom of God and the Gospel of our Lord Jesus Christ as described in the Holy Bible.
- 2) To follow, apply, teach, instruct and preach the Holy Bible
- 3) To preach, teach, instruct, follow and apply God's love, life, freedom, joy, rest, peace and ministry which results from a relationship with the Trinity; God, the Father, the Son and the Holy Spirit.
- 4) To develop ministries which are consistent with our stated purposes.
- 5) To prepare, empower and release people for the work of the ministry, while providing them with a spiritual covering.

This will be accomplished through worshipping, praising and praying to God, preaching, teaching, evangelism, instruction, publishing, recording, singing, productions, drama, proclaiming, prophesying, educating, training, distributing and disseminating oral and written materials, and using all other available media; radio, television, internet, and beyond; receiving, collecting and distributing funds for such purposes.

The focus of our purposes is worldwide.

The specific purposes for incorporating this organization are:

- 1) To start, establish, maintain, perform and promote crusades, conferences, seminars, teachings, studies, courses, correspondence and internet courses, educational opportunities and ministry opportunities which are consistent with our stated purposes.
- 2) To start, establish, maintain, perform and promote churches, cell churches, home-based churches, Bible study groups, and ministry groups.

- 3) To examine, test, educate, train, teach, administer, recognize, license, ordain, send out and provide spiritual coverings for Churches, Ministries, Ministers of the Gospel, Apostles, Prophets, Evangelists, Pastors, Teachers, Elders, Deacons, Missionaries, Chaplains and Workers who are in harmony with the purposes, doctrines and polices of this corporation.
- 4) To perform weddings, funerals, pastoral counseling, baptisms, the Lord's Supper and the general and specific work of ministry as directed in the Holy Bible. To feed, clothe, and house the poor, the homeless, widows and/or orphans. To provide ministry to prisoners and their families. To perform the duties of mentoring and aid in securing or providing employment.
- 5) To start, establish, maintain, perform and promote fellowships or associations of churches and to join fellowships or associations of churches that are in agreement with our doctrine.
- 6) To start, establish, maintain and promote radio, television and advanced media stations, broadcasts, messages, teachings, etc. in accordance with the stated purposes of this corporation.
- 7) To publish, print, compile, record, distribute and disseminate books, booklets, libraries, pamphlets, tracts, music, merchandise, periodicals, publications, newsletters, video/audio tapes, CDs literature and any other media to support and accomplish our stated purposes.
- 8) To provide training, instruction, mentoring, ministry and all other preparation for living life in general and the Christian life in particular, as defined in the Holy Bible.
- 9) To exhort mankind to be reconciled to God and to warn mankind of the impending danger of living a life apart from acknowledging God.
- 10) To raise funds, receive contributions and distribute them in accordance with promoting and securing our stated purposes.
- 11) To advertise, receive, hold, invest, transfer, rent, sell, lease and manage property.
- 12) To engage in such other trades or businesses, whether related thereto or not, for the purpose of supporting the religious, educational and charitable efforts of this corporation.
- 13) To start, establish, maintain, perform and promote retreat centers, hotels, hospitals, campgrounds, clinics, medical facilities, etc. in accordance with our stated purposes.
- 14) To travel to the nations of the world with the message consistent with the message of the Holy Bible.
- 15) To start, establish, maintain, perform and promote institutions of education and higher learning, daycare schools, schools, colleges, seminaries, universities, correspondence and internet schools, Bible schools, schools using video, audio, internet, correspondence, and all other available media.
- 16) To examine, educate, train, teach, instruct, graduate, confer certificates of completion, diplomas, and all other degrees of higher learning, such as the bachelor, masters and doctorate degrees along with any other degrees.
- 17) To offer grants and scholarships in accordance with our stated purposes.
- 18) To start, establish, maintain, perform and promote counseling and support centers.
- 19) To start, establish, maintain, perform and promote missionary boards.

ARTICLE IV - (Statement of Faith)
IRS 501 (c) (3)

- 1) We believe the Holy Bible to be the inspired, the only infallible, authoritative Word of God.
- 2) We believe that there is one God, eternally existing in three persons: Father, Son and Holy Ghost.
- 3) We believe in the Deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious sufferings and atoning sacrifice through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father and in His personal return in power and glory.
- 4) We believe that for the salvation of lost and sinful humanity, regeneration by the Holy Spirit is absolutely essential.
- 5) We believe that the full gospel includes holiness of heart and life, healing for the body, and baptism in the Holy Spirit with the initial evidence of speaking in tongues as the Spirit gives utterance.
- 6) We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a holy life.
- 7) We believe in the resurrection of both the saved and the lost, they that are saved unto the resurrection of life and they that are lost to the resurrection of damnation.
- 8) We believe in the spiritual unity of believers in our Lord Jesus Christ.

ARTICLE V - (Manner of appointment of Directors)
F.S. 617.0202 (1) (d)

The registered agent shall appoint the Board of Directors, being a minimum of three (3).

ARTICLE VI - (Initial Directors/Officers)
F.S. 617.0202 (2) (a), IRS 501 (c) (3)

ARTICLE VII- (Duties of the Board of Directors)
F.S. 617.0202 (1) (e), IRS 501 (c) (3)

All corporate powers as stated in F.S. 617.0302 and actions required to promote and support our stated purposes will be exercised under the authority of the Board of Directors. The president of the corporation has the authority to manage the day-to-day business affairs of the corporation.

ARTICLE VIII- (Internal Revenue Information)
F.S. 617.0202 (2) (f), IRS 501 (c) (3)


1. Everything Under The Son Ministries, Inc. is a Florida Corporation organized and operated exclusively for religious, educational and charitable purposes.
2. The religious beliefs of this organization as stated in Article IV (Statement of Faith) are truly and sincerely held.
3. The practices and procedures associated with our Statement of Faith are not illegal or contrary to clearly defined public policy.
4. Our Statement of faith is in agreement with that of the recognized "Pentecostal/Charismatic Churches of North America (PCCNA). The Assemblies of God, Church of God along with many other great organizations are members of the PCCNA.
5. Everything Under The Son Ministries, Inc. is organized and operated for the advancement of religion, while lessening the burdens of government and lessening neighborhood tensions by caring for and ministering to the poor and needy.
6. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in ARTICLE III - (Statement of Purposes) hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
7. In the event of the dissolution of Everything Under The Son Ministries, Inc., any assets of this organization remaining thereafter shall be conveyed by the majority vote of the Board of Directors to such other organization(s) as is best fitted, in the opinion of the majority of the Board of Directors, to carry on the purposes (or purposes closely allied thereto), of this organization. Any successor organization shall, at the time of designation, be exempt under section 501 (c) (3) of the Internal Revenue Code.
