

Article VIII Members Members of the Corporation shall be chosen, maintained and removed as stated in the Bylaws. Members of the Corporation shall not have any authority or powers nor voting rights. Article: IX: IRS Language

Said corporation is organized exclusively for charitable, religious, educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth.

No part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

- (a) by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code, or
- (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

Article X: Pastoral Care and Leadership

The Lead Pastor shall be the spiritual leader of the church. The qualifications, process and vote required to approve a Lead Pastor shall be contained in the Bylaws. The Board of Directors are authorized to purchase, mortgage, encumber, and sell part or all the Corporations real property and personal assets. The Board of Directors are also authorized to apply for all Federal, State and local grants and financial assistance and aid to supplement our community outreaches.

Article XI: Dissolution

Upon the dissolution of the organization, none of its funds or assets shall be distributed to any director, officer, deacon, trustee, member or any other individual. The church board shall, after paying or making provision for the payment of all the liabilities of the church, distribute funds and assets for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such funds or assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such religious purpose.

Article XII: Amendment

This corporation reserves the right to amend, alter, change or repeal any provision contained in the Articles of Incorporation, or any amendments hereto, and to enact a Constitution and By-Laws, in manner now or hereafter prescribed by law and all rights conferred on Directors and Officers herein are granted subject to this reservation. These Articles of Incorporation may be amended at any time by a 2/3rds vote of the Board of Directors at any regular or at a special meeting called for that purpose.
