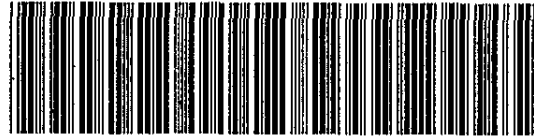

We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to being appointed, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to Chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be The Sprit Of Truth And Faith, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 1933 West Walnut Street Tampa, Florida 33607.

ARTICLE III: PURPOSE

ARTICLE VIII: BY-LAWS


The By-Laws of this corporation shall be made by the board of Directors and may be amended or rescinded as provided therein.


