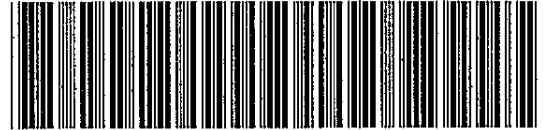



# **Nonprofit Articles Of Incorporation**

## **For**

### **Praise & help International Inc.**

---

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### **Article I**

##### **Name**

The name of the corporation shall be:

**Praise & help International Inc.**

#### **Articles II**

##### **Principal office**

The principal place of business and the mailing address of this corporation shall be:

**12180 Fuller Lane  
Naples FL. 34113**

#### **Articles III**

##### **Purposes**

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, Literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### **In Florida**

- a) To Conduct Social and Evangelical Activities.
- b) To assist poor families and unemployed persons.
- c) To Provide food, clothing, emergency cash assistance and shelter to needy & homeless individuals.
- d) To Provide Counseling services.
- e) To Provide youth and family services.
- f) To Provide Information & referral services.

### **In Haiti**

- a) To help needy children stay in school.
- b) To build orphanages.
- c) To feed disadvantage families.

- e) To provide medical assistance to students, adults and others who cannot afford medical care.
- f) To build churches.
- g) To build vocational schools.
- h) To assist the little farmers & their farms in producing more and improving their life conditions.

### **Articles IV**

#### **Manner Of election Of Directors**

The manner in which the directors are elected or appointed shall be stated in the Bylaws of the corporation.

### **Articles V**

#### **Limitation of corporate powers**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

### **Articles VI**

#### **Dedication Of Assets**

No part of the net income or assets of the corporation shall inure to the benefits of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation in carrying out one or more of its purposes.

### **Articles VII**

#### **Prohibition Against Political Activities**

No substantial part of the activities of the corporation shall be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

## **Article VIII**

### **Distribution Of Assets Upon Dissolution**

Upon the dissolution of the corporation, the board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all assets of the corporation in such manner, or to such organization or organizations organized and operated exclusively or charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organizations under Section 501 (c) (3) of the internal revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court in and for Collier County, Florida, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.

## **Articles IX**

The principal place and business of this corporation shall be located in the city of Naples, Collier County Florida, and it may have such other places of business, both within and without the State of Florida and in Foreign countries, as might be necessary or convenient.

## **Articles X**

The business of this corporation shall be conducted by a board of Directors of not less than three (3) Directors, the exact number of Directors to be fixed by the by-laws of this corporation. The board of Directors shall have the powers to make, alter, or rescind the corporation by-laws. The board of Directors is all elected by a majority vote of the membership.

## **Articles XI**




