- ONE: The name and address of this principal corporation is MAHANAIM HOUSE OF PRAYER BODY OF CHRIST, INCORPORATED. 7195 Northwest 7<sup>th</sup> Avenue, Miami, Florida 33150, Dade County. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.
- TWO: This corporation is a non profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self sufficiency. The program shall consist of, but not be limited to: Economic Development, Community Enrichment, Social Reconstruction, Career Development, Scholarship, Youth at High Risk, Education, Tutoring, Literacy, and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.


