#### ARTICLE XI - DISSOLUTION OF THE CORPORATION

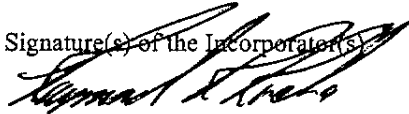

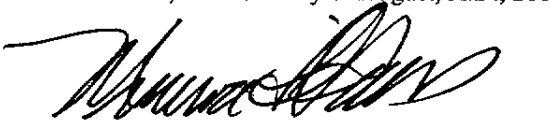

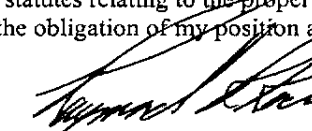
