We, the undersigned incorporator(s), hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, adopts the following articles of incorporation.

**ARTICLE I            NAME**

The name of this corporation shall be **NEWNESS OF LIFE TEMPLE OF FAITH, INC.**

**ARTICLE II           ADDRESS**

The location of this corporation shall be **2154 Adam's Street, Palm Bay, FL 32905**

**ARTICLE III          PURPOSE**

This corporation is organized exclusively for the purpose of conducting religious worship and instructing churches, schools, pastorioms, childcare center, building improvement projects, and other institutions connected therewith of a religious, educational, charitable and benevolent character. To the end that its own members and others may be generally instructed and guided concerning those articles of faith which are more surely held among Christian churches and to advance spiritual growth and enlightenment, moral and personal more specifically to educational. The corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501©3 of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions or organizations that qualify as exempt organizations under Section 501©3 of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. The purposes also include the right to buy, rent, lease, sell, and own properties and institutions to accomplish the above stated purposes.

1. **NOL'S TENDER CARE** shall provide the following services:

a. **NOL'S TENDER CARE** – to provide quality, low-income and twenty-four hour day care for the working population who qualify for reduced service.

We will provide a service for the mildly-disabled babies and individuals who need care. Licensed and qualified providers will service the clients and individuals who qualify.

b. **NOL'S TENDER CARE PRESCHOOL** - is an extension to the worship experience of **NEWNESS OF LIFE TEMPLE OF FAITH, INC.** and continues to provide charitable, educational and literary service to provide tutoring, mentoring, coaching and early childhood prevention to mothers-in-waiting (maternity).

2. **ADULLAM'S REFUGE** is a building construction program for new housing and renovation program for old rundown dwellings which need renovation. It shall be a new beginning for individuals who need quality living quarters.

#### **ARTICLE IV MANNER OF ELECTION**

This corporation shall have perpetual existence. The corporation shall have a President, Vice-President, Secretary, and Treasurer and such other officers as deemed necessary, and such other officers shall be elected by a 2/3 majority vote of the corporation present at any business meeting of said corporation for such term as the corporation may provide by its By-Laws.

**ARTICLE VII            MEMBERSHIP/BOARD OF TRUSTEES**

Each person who believes in repentance toward God, and faith in the Lord Jesus Christ as Savior and Lord, and who is willing to confess Him publicly as Lord and King and follow him, and to observe the ordinances of the church and Christ and to be governed by his laws, is qualified and eligible to participate as a member in the corporation. The manner of admission to membership in said corporation shall be by public confession of Jesus Christ as Savior and Lord. The present membership of ***NEWNESS OF LIFE TEMPLE OF FAITH, INC.*** and those hereafter admitted to such membership constitute the membership of the corporation.

The affairs of this corporation shall be managed by a Board of Trustees, such management to be subject to the approval of the church. The said Board of Trustees shall be elected from and by the membership of said corporation. The term of membership of Trustees shall be for life, or for such other length of time, not less than one year, as the membership of said corporation may provide in its By-Laws. The incorporators, also known as Board of Trustees, shall appoint from its own membership a Chairman, Vice-Chairman and Secretary. All legal instruments of the corporation shall be signed by said Chairman, sealed with the corporation seal and attested by said Secretary; or in such other manner as may be authorized by law. All elections to membership of said Board of Trustees shall be a 2/3 majority vote of the members of the corporation present at any business meeting of the said corporation.

The present Board of Trustees of ***NEWNESS OF LIFE TEMPLE OF FAITH, INC.***, the incorporators hereof, namely Darrell L. McMillan, Jessie L. McMillan, Patricia Smith, Laquashe Graham, and Angela Littles shall constitute the Board of Trustees and shall hold office until their successors are elected and qualified by measures set forth by the church's legal team.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501©3 of the Internal Revenue Code of 1986, or the Corresponding provisions of any future United States Internal Revenue Law.

**ARTICLE VIII            BY-LAWS**

The By-Laws of ***NEWNESS OF LIFE TEMPLE OF FAITH, INC.*** are to be made, altered or rescinded upon a two-thirds vote of the members present at any annual meeting of the corporation.

**ARTICLE IX****DISSOLUTION**

Upon dissolution of the Corporation, the Board of Trustees shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, all assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the Federal, State, or local government for a public purpose. In no case shall a disposition be made which would not qualify as a charitable contribution under Section 170(c)(1) or (2) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, in such manner as the Board of Trustees shall determine.

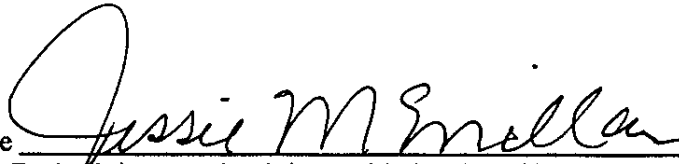
