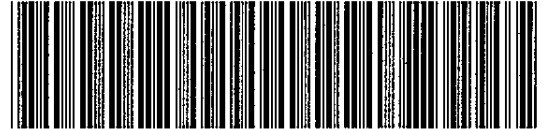

ARTICLES OF INCORPORATION  
OF

ARTICLE I

The name and address of this corporation is St. Hilda's Home Care, Inc., 4250 SW 53rd Avenue Davie, Florida 33314, Broward County. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE II

The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes to aid the poor and disadvantage individuals and families towards a life of self-sufficiency. The programs will consist of, but not limited to: Elderly Care, Child Care, Job Training, Job Placement, Land Acquisition, Housing, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, Aids and other programs to aid those in need.

ARTICLE III

The duration of this corporation shall be perpetual, no stock and shall have no members.

ARTICLE IV

#### ARTICLE VII


