- 1. **Article III**, re: Organization Purpose, is to be amended to add the following sentence to the original sentence, beginning after the last word "ministry": and for exclusively charitable religious and educational purposes in accordance with Section 501(c)(3) of the Internal Revenue Service Code or corresponding section of any future code
- 2. **Article VIII,** to be added and titled, "Distribution of Assets", and to read as follows:
