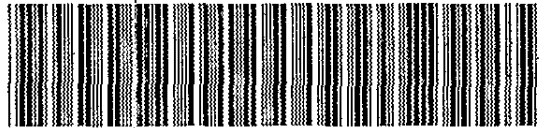

Article I: NAME

Silver Ridge Estates Neighborhood Association, Inc.

Article II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

Article III: PURPOSE

The purposes for which the corporation is organized are:

To preserve and enhance the Silver Ridge Estates Neighborhood as a desirable residential community;

To uphold and protect the value of homes and natural beauty of the neighborhood;

To promote sound planning and zoning and to oppose detrimental zoning or zoning changes within and surrounding the neighborhood;

To provide a forum for the homeowners and renters with established residency who have opinions and to make these opinions known to the general public and to the city and county official on topics of concern;

To enter into contracts; and

To do all things necessary to accomplish the objective enumerated above.

Article IV: MANNER OF ELECTION

The election of officers and directors shall be by ballot at the meeting to be held during the second quarter of each calendar year. However, if there is but one nominee for any office or director position, the chairman (person) of the Nominating Committee shall cast the elective ballot for that nominee.

There shall be a Nominating Committee composed of three (3) members of the association. The Nominating Committee shall be appointed by the president to serve until the next year's Nominating Committee is appointed.

The Nominating Committee shall nominate at least one eligible consenting person for each office and shall make choices known at the quarterly meeting of the calendar year. Additional nominations for each office may be made and accepted from members at that meeting.

The nominee receiving the largest number of votes shall be declared the winner. Absentee or proxy voting shall not be permitted.

Vacancies shall be filled by the President until the next election held during the second quarter of the calendar year.
