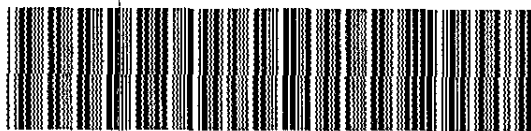

-The directors of the entity will be appointed or confirmed by the Board of Administration.




