Today, January 13<sup>th</sup>, I spoke with somebody in the Division of Corporations about the dissolution of Citizens Speaking Out, Inc.

The Annual Report for 2005 was rejected due to missing information on the form. A letter from the Division of Corporations dated September 13<sup>th</sup>, 2005 indicating that you had received the report along with the check for \$61.25 and requesting the missing information was not received by us. Consequently, Citizens Speaking Out, Inc. was dissolved.
