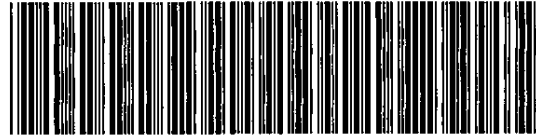

Housing Enhancement for Lower Income People, Inc

ARTICLE I - Title

The name of the organization shall be the Housing Enhancement for Lower Income People, Inc. The corporate headquarters is located at 1121 N.W. 182nd street, Miami, Florida 33147. The organizations may also be referred to as HELP. The organizations mailing address is PO Box 141172, Orlando, FL 32814-1172.

Article II - Purpose

The corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes within the meaning of Section 501(c) 3 of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501 (c) (3) exempt organizations. To this end, the corporation shall provide affordable housing to lower-income people while directing said individuals and families toward home ownership through education and lifestyle adjustments. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

Article III - Limitations

At all times the following shall operate as conditions restricting the operations and activities of the corporation;

1. No part of the net earnings of the corporation shall be given to any entity not qualifying as exempt under Section 501 (c)(3) of the Internal Revenue Code, as now enacted or hereafter amended, nor to any Director or officer of the incorporation, nor to any other private person, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditure incurred on behalf of the corporation;
2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statement), any political campaign on behalf of, or in opposition to, any candidate for public office; and
3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Service Code of 1986, as now enacted or hereafter amended
4. The corporation shall not lend any of its assets to any officer or director of this corporation (unless such loan program is regularly conducted as part of the activities of the organization and the qualification of the individual to participate in same is determined by a panel comprised solely of non-board members), or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE IV DIRECTORS/MEMBERS

The corporation shall have no voting members. The management and affairs of the corporation shall be at all times under the direction of the Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by laws. No Director shall have any right, title, or interest in or to any property of the corporation.

ARTICLE V
DEBT OBLIGATIONS AND PERSONAL LIABILITY


No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VI
DISSOLUTION

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501 (c) 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of Competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purpose.

ARTICLE VII
INCORPORATOR

The incorporator of this corporation is Othniel A. Edwards, 2454 Kathi Kim Street, Cocoa, and FL 32926. The undersigned incorporator certifies that he will execute these Articles for the purposes herein stated, and that by such execution, he affirms the understanding that should any of the information in these Articles be intentionally or knowingly misstated, he is subject to the criminal penalties for perjury.
