ARTICLE I.

THE NAME of the corporation:

First Methodist Church of Crestview, Inc.

ARTICLE II.

THE PURPOSES for which the corporation is formed are as more fully set forth in the Discipline of the Global Methodist Church or as may be amended from time to time, including:

- a. To foster the doctrines and teachings of the Christian Faith, with the right to establish and conduct schools and day care and, further, to propagate the Gospel as found in the Holy Bible, and to teach the truths of the Christian religion.
- b. To conduct and carry on various plans, efforts and undertakings for the spiritual, moral and social well-being of its members and the community in which it serves.
- c. To own and maintain a place or places of worship and meeting for its members, and to own any other real estate provided for in the organization of the church.
- d. To acquire, lease, purchase, own, use, sell, convey, exchange, mortgage, improve, develop, and otherwise deal in and dispose of real property, personal property, choses in action, notes, bonds, securities, and/or any interest as provided.
- e. To borrow money, with or without security, to execute mortgages and trust indentures, to execute and issue bonds, notes, mortgages, certificates, and other evidences of indebtedness, secured by any or all of the assets of the corporation.
- f. To adopt and/or amend by-laws for the church and admission of its members.
- g. All in accordance with the doctrines, laws, usages, discipline and ministerial appointments of the Global Methodist Church.
