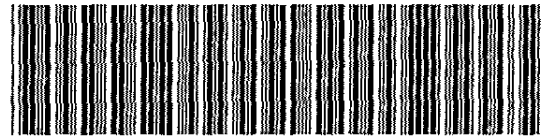

Article III Purpose

The nature of the business and the objects and purposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis:

This is a nonstick, non profit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organize3d under the General Corporation Law of Florida.
