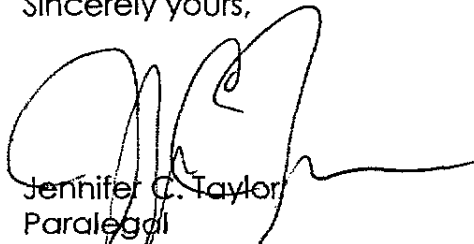

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I - NAME**

The name of the corporation shall be:

Pace/ Floridatown Historic Preservation, Incorporated

**ARTICLE II - PRINCIPAL OFFICE**
