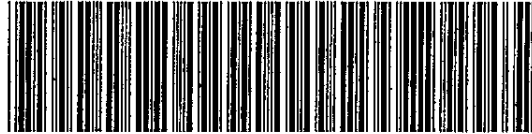

ARTICLES OF INCORPORATION

ARTICLE I

Name of Organization

The name of this organization shall be Polk County Gay and Lesbian Alliance Inc.

ARTICLE II

Principal Office

The principal place of business and mailing address for this corporation shall be our PO Box 2683 in Lakeland, FL 33806. Meeting places will vary from month to month as to where our events will be held.

ARTICLE III

Purpose of the Organization

The Corporation will serve to provide a means of raising funds through charitable activities. These funds will be made available to the community to support organizations and groups who provide for persons with HIV/AIDS and /or other organizations who provide support to the Gay and Lesbian community. These organizations must qualify as an exempt organization under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

In addition "PCGLA" will also promote as gay and lesbian citizens of Polk County, FL a social organization that meets monthly for various events including potluck dinners, a bowling league, dining out at area restaurants as a group, hosting support groups and our annual anniversary celebration.

ARTICLE IV

Manner of Election

The manner in which the directors are elected or appointed are elections for officers and directors will be held at the monthly general meeting in May. The secretary will announce nominations for the election three months prior and every month up to the elections. Installation of directors and officers will be held in September at our annual anniversary celebration.




