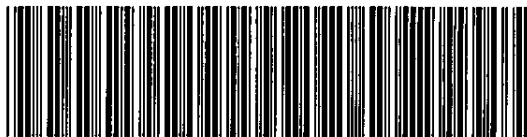

I, the undersigned, being the President, of NewsManatee, Inc., a Florida corporation, with Articles of Incorporation filed on August 27, 2004, hereby certify that the following Amendments were unanimously adopted by the members of the corporation at a meeting held on the 11th day of May, 2007.

The following Article of Incorporation is amended:

Article III

The following are the purposes for which this corporation has been established:

- (1) Active participation in the development and direction of any and all acts and activities which would affect the safety of the residents of Manatee County and the Suncoast.
- (2) Encourage programs or proposals which would be beneficial to the safety of the resident of Manatee County and the Suncoast.
- (3) Appoint reporters to investigate and report on special subjects relative to the conduct of law enforcement and government officials with regard to the purposes of the organization.
- (4) Promote and encourage the exchange of information on health and safety issues from the community and law enforcement to each other.
- (5) Promote and enhance the general safety and well being of all residents of Manatee County and the Suncoast.
- (6) To educate the public on their rights with regard to city, county and state health and safety matters.

The following Article of Incorporation is added:

Article VIX

In case this organization wishes to dissolve and by due process of law shall dissolve, all assets of whatever nature or their equivalent in value which remain after just debts and liabilities of this organization have been satisfied shall be used for such civic or public purpose or purposes within the State of Florida as will complete or continue undertakings for the public benefit which already have begun by the organization and any remaining assets shall be distributed for purposes within the scope of Internal Revenue Service Statute 501(c) (3) or any amendments thereto. No part of the net income or earnings of the organization shall inure to the benefit of any individual member or be distributed to its members or officers/directors.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
