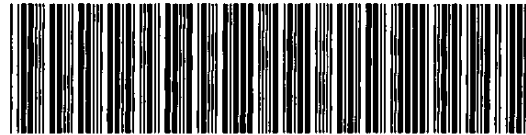

I, the undersigned, being the President, of NewsManatee, Inc., a Florida Not for Profit Corporation, with Articles of Incorporation filed on August 27, 2004, hereby certify that, pursuant to the provisions of section 617.1006, the following Amendments were unanimously adopted by the members of the corporation at a meeting held on the 13th day of September, 2007. The following Articles of Incorporation are amended:

Article I
NEWSMANATEE, INC.

Article III

The purposes for which this corporation has been established are:

- (1) Active participation in the development and direction of any and all acts and activities which would affect the safety of the residents of Manatee County and central Florida.
- (2) Encourage programs or proposals which would be beneficial to the safety of the residents of Manatee County and central Florida.
- (3) Appoint reporters to investigate and report on special subjects relative to the conduct of law enforcement and government officials with regard to the purposes of the organization.
- (4) Promote and encourage the exchange of information on health and safety issues from the community and law enforcement to each other.
- (5) Promote and enhance the general safety and well being of all residents of Manatee County and central Florida.
- (6) To educate the public on their rights with regard to city, county and state health and safety matters.

Article VIX

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal

government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.

Under penalties of perjury, I declare that I have examined this information, including accompanying documents, and, to the best of my knowledge and belief, the information contains all the relevant facts relating to the request for the information, and such facts are true, correct, and complete.
