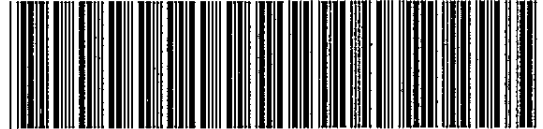

(Amended February 8, 2005)

### **In Compliance with Chapter 617, F.S., (Not for Profit)**

#### **Article I NAME:**

The name of the non-profit organization shall be:

#### **Article III PURPOSE:**

The purpose for which the organization has been unified is:  
Latino Communication Service Agency Inc. is an organization committed to provide empowerment and of low income Hispanic and non-Hispanic individuals and families by initiating, participating in and developing resources through educational knowledge, vocational, health care, employment and other programs. LCSA was created with one main objective. We want to facilitate growth and personal enhancement within the community. Our agency recognizes the need in our area for a centralized location. The overall goal is to facilitate emotional, personal and cultural growth and well being by presenting these types of courses in both Spanish and English. We, LCSA Directors/officers and any other employees shall ~~not~~ distribute propaganda, or otherwise attempt to influence legislation or intervene (including distribution of statements) to any political campaign on or behalf of any candidate for public office. This agency was formed for the above purpose and all earnings of the organization shall benefit the charitable goal of the agency. No part of the net earnings of the organization shall benefit or be distributable to its members.

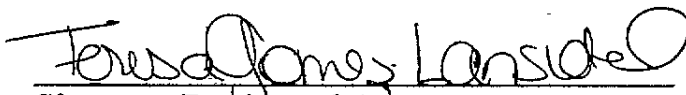
