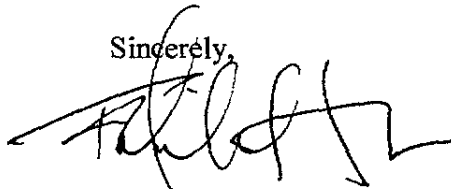

Name

- A. This corporation is a nonprofit corporation and is not organized for the private gain of any person.
