ARTICLES OF INCORPORATION OF

MADISON COUNTY SOCCER ASSOCIATION, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida applicable to corporations not for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Articles of Incorporation.

ARTICLE I.

NAME

The name of this corporation shall be MADISON COUNTY SOCCER
ASSOCIATION, INC., and its initial principal office shall be 111 West Pinckney Street,
Madison, Florida 32340.

ARTICLE II

PURPOSES .

The corporation is organized to foster national and international amateur competition in the sport of association football (soccer) and primarily to support and develop amateur athletes for that competition and for related purposes of recreation for children. Pursuant to this the corporation will promote, govern, coordinate, and administer the sport of association football (soccer) in Madison county, Florida; provide for the continuing development of association football players, coaches, referees, and administrators; and provide for the prompt and equitable resolution of grievances.

ARTICLE III.

AUTHORIZED SHARES OF STOCK

This corporation shall issue no stock.

ARTICLE IV.

LIMITATION OF ACTIVITIES

No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law.

ARTICLE V

DISSOLUTION

On the dissolution of this corporation the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for recreation purposes for children and that shall at the time qualify as

exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for recreation purposes for children.

ARTICLE VI.

USE OF REVENUE

All revenue, profit, income and money received from the conduct of this corporation is to be used and employed for the purposes herein set forth, and not for the benefit of the members of this corporation, either individually or collectively.

ARTICLE VII.

POWERS.

This corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of this corporation and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations of similar character under the law of the State of Florida.

ARTICLE VIII.

RESTRICTIONS

The activities of this corporation shall be limited to the purposes herein set forth, and other purposes that permit a corporation to qualify as a tax exempt organization under Section 501 (c) (3), of the Internal Revenue Code as presently

enacted or might hereinafter be amended. Any activity in violation of such section of law is strictly prohibited.

ARTICLE IX.

QUALIFICATIONS FOR MEMBERSHIP

Membership in this corporation is open to any person who is a parent or quardian of a child registered for the programs of this corporation.

ARTICLE X.

TERM OF EXISTENCE

This corporation shall have perpetual existence, and shall commence its corporate existence as of the date of the filing of these Articles.
