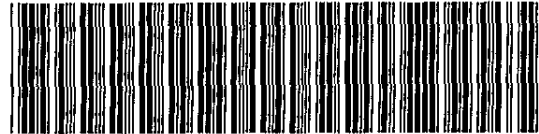

ARTICLE I NAME

The name of the corporation shall be: World African Cultural Union/USA, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III DURATION

The period of duration of the World African Cultural Union/USA, Inc. is perpetual unless dissolved according to the corporation's Bylaws.

ARTICLE IV PURPOSE

The purpose for which the World African Cultural Union/USA, Inc. is organized is: to create a community which will blend African tradition with modern and post-modern scientific and technical achievements and to create the environment where people of the new Imobi, Nigeria community will organize themselves with the goal of creating avenues through which members will be able to contribute their knowledge and skills, first to the people of Imobi and then to the community-at-large throughout Nigeria and the United States.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The World African Cultural Union Bylaws shall regulate the manner in which the directors are elected or appointed, and the qualifications for membership.

ARTICLE VI LIMITATION OF CORPORATION POWERS

The corporate powers of this corporation as are provided in Section 617.0302, Florida Statutes, unless limited by the World African Cultural Union/USA, Inc. Bylaws.

Pursuant to Chapter 617, Florida Statutes, the World African Cultural Union/USA, Inc. may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, and the corporation is empowered to sue and be sued, and appear and defend in all actions in the name of World African Cultural Union/USA, Inc.; elect or appoint officers; make contracts and incur liabilities; carry on its operations in the United States and any foreign country; hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received or in the ByLaws of the World African Cultural Union/USA, Inc.
