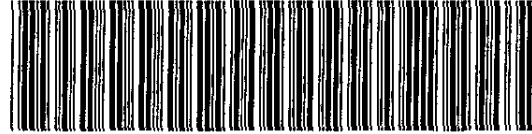

ARTICLES OF INCORPORATION

OF

NORTH LAKELAND VOLUNTEER FOOTBALL LEAGUE, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

I

The name of the corporation shall be *NORTH LAKELAND VOLUNTEER FOOTBALL LEAGUE, INC.*. The principal place of business shall be 2020 Duff Road, Lakeland, Florida 33810.

II

The duration of this corporation is perpetual unless dissolved according to law.

III

The purposes for which this corporation is organized are:

1. To assist, promote, sponsor, educate, train, and finance a team or teams of boys and girls for amateur recreational sports and cheerleading, and to do other charitable activities with and for them, and to support youth and youth activities and to assist and cooperate with other organizations devoted to such endeavors and to assist and cooperate with all other charitable organizations.

2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.

3. The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary, and/or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

4. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

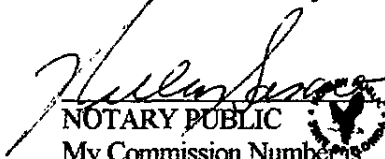
