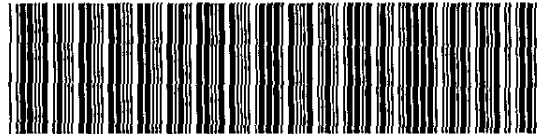

ARTICLES OF INCORPORATION

In Compliance with chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation:

A proper ballot should be made to indicate the name of the individuals running for the post, if there are more than one, indicate all the names on the ballot. Majority vote decides the results for each position within the executive committee.
