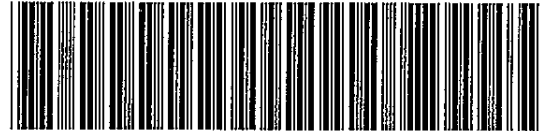

The undersigned, for the purpose of forming a not for profit corporation, in compliance with Chapter 617, Florida Statutes, hereby states:

ARTICLE I – NAME OF CORPORATION

The name of the corporation is: Coalition to Save Florida Jobs, Inc. (hereinafter referred to as the "Corporation.")

ARTICLE II – PRINCIPLE OFFICE

The street address of the initial principal office and mailing address of the Corporation is: 215 South Monroe Street, Suite 505, Tallahassee, Florida 32301. The Corporation may from time to time move its principal office to another location.

ARTICLE III – PURPOSE

The Corporation is organized and shall operate exclusively for the promotion of social welfare within the meaning of Section 501(c)(4) of the Internal Revenue Code.

ARTICLE IV – ELECTION OF DIRECTORS

The directors of the Corporation shall be elected as provided in the bylaws of the Corporation.

ARTICLE V – INITIAL DIRECTORS

ARTICLE VI – INITIAL REGISTERED AGENT

The name and address of the initial registered agent of the Corporation are: H. Darrell White, 305 South Gadsden Street, Tallahassee, Florida 32301.

ARTICLE VII – INCORPORATOR

The name and address of the incorporator are: H. Darrell White, 305 South Gadsden Street, Tallahassee, Florida 32301.

ARTICLE VIII – OPERATIONAL LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. Notwithstanding any other provision of these articles, this Corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation or that are not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(4) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX – TERM OF CORPORATE EXISTENCE

The Corporation shall exist perpetually unless dissolved according to law. Upon dissolution of the Corporation, assets may be distributed to: a not for profit fund, foundation, or corporation that is organized exclusively for either charitable or social welfare purposes, having established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code; or, to an entity organized for a similar purpose as the Corporation and exempt from taxation under Section 501(c)(4) of the Internal Revenue Code.
