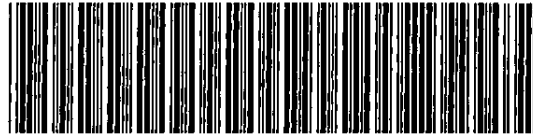

b. have power to solicit and raise funds by any and all proper and appropriate means, in accordance with and subject to the Religious Corporation Law, and to receive such funds of money accruing from offerings, or any other contributions for the general support of said church corporation.

c. have power to take, purchase, lease or otherwise acquire real estate; and to hold, own, sell, mortgage, lease, or otherwise dispose of same; and to have power to build, construct, maintain, alter and manage any building or church edifice for the uses or purposes of said corporation.

To have power to transfer or convey any of its properties to any branch church connected with this corporation, and to establish or maintain, or to assist in the establishing or maintaining of branch churches, in erecting buildings as may be necessary for such purposes with or without payment of money or other considerations..


Article v. being amended: Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government, for a public purpose.
