

PLAN OF LIQUIDATION

- 1. This Corporation shall be dissolved and liquidated on or prior to August 31, 2011.
- Upon the adoption of this Plan of Liquidation by the members of the board of directors the proper officers of the Corporation shall execute and file Articles of Dissolution with the Florida Department of State.
- 3. All debts, liabilities and obligations of this Corporation shall be paid and discharged, or adequate provision made for payment or satisfaction thereof.
- 4. On or before August 31, 2011, the Corporation shall transfer all of its remaining assets, as follows:
 - (a) \$750 to the School of the Arts Foundation, Inc., a Florida not-for-profit corporation and tax-exempt within the meaning of Section 501(c)(3) of the Internal Revenue Code; and
 - (b) \$750 to the Students in the Arts TV/G-Star TV, Inc., a Florida not-for-profit corporation and tax-exempt within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- 5. The amount of \$263.00 shall be retained and held by the Corporation in its accounts for a period not to exceed three (3) months for the payment of any contingent or unknown liabilities. Upon expiration of said period, any remaining corporate funds shall be distributed to Cystic Fibrosis Foundation, a Delaware not-for-profit corporation and tax-exempt within the meaning of Section 501(c)(3) of the Internal Revenue Code or one or more exempt organizations within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- 6. The proper officers of this Corporation shall take all actions necessary to distribute the foregoing assets and to effect the dissolution and liquidation of the Corporation.
