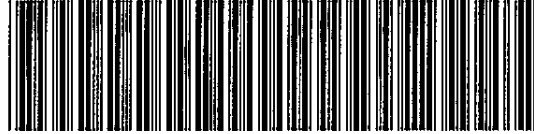

ARTICLE I - NAME

The name of this Corporation is: The Center in Tampa, Inc.


