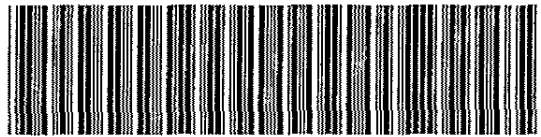

**Articles of Incorporation**  
of  
**Generations 246 Church, Inc.**

To the Secretary of State of the state of Florida in compliance with Chapter 617, F.S., (Not for Profit):

**Article I Name**

The name of the Corporation shall be **Generations 246 Church, Inc.**

**Article II Principal Office**

The principal place of business and mailing address of this corporation shall be **6345 Pacific Street, Omaha, NE 68106.**

**Article III Purpose**

The purposes for which the corporation is organized are:

A. The Corporation is a religious corporation organized exclusively for religious, charitable and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Law).

B. To receive and administer funds for religious, charitable and educational purposes and to that end to take hold, bequest, devise, gift, grant, purchase, lease, or otherwise, either absolutely or jointly with any other person, persons, corporations, any property, real, personal, tangible or intangible, or any otherwise dispose of any such manner as, in the judgment of the Directors, will best promote the purposes of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the Bylaws of the Corporation, or any laws applicable thereto.

C. Without limiting the generality of the foregoing, the principal purpose of the Corporation shall be to organize, operate and maintain a Church in the Community of Fort Walton Beach, FL, for the purpose of carrying out the following Vision Statement: **Treasuring God by Enjoying and Proclaiming the Excellency of Jesus Christ to All Generations.**

D. In general, to do any and all acts and things, and to exercise any and all powers which it may now or hereafter be lawful for the Corporation to do or exercise under and pursuant to the laws of the State of Florida for the purpose of accomplishing any of the purposes of the Corporation.

E. The purposes for which the Corporation is organized shall be confined to those which are strictly religious, charitable and educational.

#### **Article IV Manner of Election**

The manner in which the directors are elected or appointed shall include the number, qualifications, terms of office, method of election and removal, and shall be varied from time to time as set forth in and with amendment to the Bylaws.
