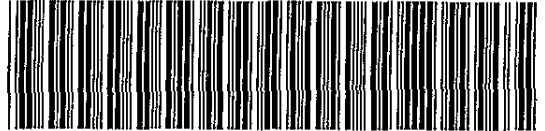

Of

A Florida-Non-Profit Corporation**

**Article I
Name**

The name of this corporation shall be: **"B & B Foundation For Education, Inc."**

**Article II
Principal Office**

The Principal place of business and the mailing address of this corporation shall be:

**Article III
Purposes**

This corporation is a not-for-profit Corporation, organized for educational and charitable purposes, including but not limited to the following:

1. To assist in the development and education of the poor children living in Haiti.
2. To receive, administer, invest and apply gifts, donations, and contributions in various forms; to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or indirectly to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Service Code and regulations issued pursuant thereto as they now exist or as they may hereafter be amended.
3. To promote and improve and educate the poor children of Haiti.

Article IV

Membership

Any person, corporation, partnership, association or organization who is interested in the purposes of the corporation who is capable of contributing to the achievement of those purposes and the effective operation of the corporation, and who complies with the requirements established in here in the Bylaws shall be eligible for membership.

Manner of Election



The corporation shall begin existence effective upon the receipt of these articles.

Article IX Dissolution

Upon any dissolution of this Corporation, its assets remaining after payment or provision for payment of all debts and liabilities of the corporation shall be distributed to a not-for-profit fund, foundation or corporation designated and operated exclusively for charitable purposes and which has established its tax exempt status under section 501 (c) (3) of the internal revenue Service Code as amended or corresponding provisions of any subsequent federal tax laws.

Article X Limitations

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers, members or other private persons (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), the Corporation shall not be engaged in the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided in subsection (h) of section 501 of the Internal Revenue Service code, and the corporation shall not participate or intervene in (Including the publishing or distributing of statements) any political campaign on behalf of any candidate or any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on:

By corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code (or the corresponding provision of any future U.S. Internal Revenue law or:


