Article I Name

The name of this corporation shall be: "B & B Foundation For Education, Inc."

Article II Principal Office

Article III Purposes

This corporation is a not-for-profit Corporation, organized for educational and charitable purposes, including but not limited to the following:

- 1. To assist in the development and education of the poor children living in Haiti.
- 2.
