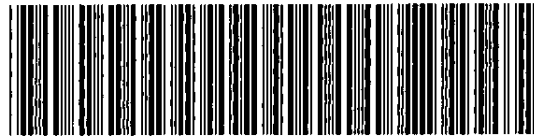

DOES HEREBY CERTIFY THAT:

- FIRST: The name of the Corporation is "OAKLAND PARK FOUNDATION, INC."
- SECOND: The Articles of Incorporation of the Corporation were filed on September 24, 2004, and assigned document number N04000009153.
- THIRD: The dissolution of the Corporation was adopted and executed by the unanimous joint written consent of all of the Members of the Corporation in accordance with Section 617.0701, Florida Statutes.
