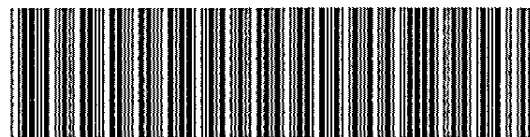



**ARTICLES OF INCORPORATION
OF
FIRST COMMUNITY CHURCH OF DADE CITY, FLORIDA, INC.**

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a non-profit corporation.

ARTICLE I

The name of this corporation shall be **FIRST COMMUNITY CHURCH OF DADE CITY, FLORIDA, INC.**

ARTICLE II

The street address and the mailing address of the corporation's initial principal office shall be 13419 McIntosh Street, Dade City, Florida 33525.

ARTICLE III

The corporation is organized for religious purposes which are not for pecuniary profit, and intends to operate a church as a Southern Baptist Congregation.

ARTICLE IV
